A standard water connection is a connection up to 32mm in diameter. This will provide up to 1 litre per second and should be sufficient for all domestic properties (flats/terrace/semi/detached houses).

It can also be used for commercial properties that don't require more than 1 litre per second, e.g. office block requiring water for kitchen and bathroom facilities only. If you're not sure you can use the flow type calculator at stwater.co.uk/newconnections to check.

Section 4 - Sewer connection(s) (Section 106 of the Water Industry Act 1991)

You only need to complete this section if you're applying for approval to connect to our sewer network.

Sewer connections are on a self lay basis where you and/or your contractor carry out the connection works and we simply inspect, approve and sign off the works. It's important we assess the completed works to understand the additional demand on our network to help us identify where we may need to upgrade our infrastructure.

You may find it easier to complete this section with your contractor as they'll be able to provide the information needed. A site specific Method Statement and Risk Assessment will be needed, which your contractor must give you so that you can send them to us with this application. We need these for any connection being made directly onto the public sewer.

If you're applying for a surface water or combined sewer connection, you'll need to send us evidence to show why it's not possible to use a soakaway.
